


Emissions reduction targets

This is our first reporting year so we cannot provide historical figures. We have included a graph below that illustrates our plan to be net zero by 2050.

In order to continue our progress toward achieving Net Zero, we have adopted the following carbon reduction targets (see graph below).

We project that carbon emissions will decrease over the next five years to 74 tCO₂e by 2029. This is a reduction of 7%.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline. The carbon emission reduction achieved by these schemes equate to (amount outstanding due to first year reporting) tCO₂e, a (amount outstanding due to first year reporting) %ge reduction against the 2024 baseline and the measures will be in effect when performing the contract.

Investing in Reforestation: We have partnered with the Ecologi program to support forestry projects aimed at restoring areas affected by human activities. A portion of our sales is dedicated to funding the purchase of trees, with an initial contribution covering 50 trees. We are committed to scaling up this effort annually, progressively increasing our impact.

Electrification of Fleet: We are actively transitioning our fleet to electric vehicles, prioritising this initiative wherever feasible. By incorporating this into our long-term targets, we aim to significantly reduce our carbon footprint associated with transportation.
